| Item 1. Introduction | <p>Topturn Capital, LLC is registered with the Securities and Exchange Commission (SEC) as an investment adviser. Brokerage and investment advisory services and fees differ. It is important for you to understand the differences. | Item 2. Relationships and Services | <p>What investment services and advice can you provide me?</p> <p>We offer investment management, wealth management, financial planning and consulting services to retail investors. We provide investment advisory services utilizing a variety of resources, such as independent investment managers, exchange traded funds (“ETFs”), and individual debt and equity securities. Additionally, we may recommend investments in private placement securities such as debt, equity and/or pooled investment vehicles to clients who are deemed “accredited investors” as defined in Rule 501 of the Securities Act of 1933. Our recommended allocation among investment alternatives is based on your investment objectives, risk tolerance, and other factors.</p> <p>Under our Investment Management Services program, we are responsible for monitoring your account(s) at least quarterly or more often as market conditions warrant. We also conduct reviews with you at least annually. For those clients to whom we provide financial planning and/or consulting services, reviews are conducted on an “as needed” basis. Our investment advisory services are offered on both a discretionary and non-discretionary basis. If you provide written authorization for us to trade on a discretionary basis, we do not need advance approval from you to determine the type and amount of securities to be bought/sold for your account(s). If you elect to have your account managed on a non-discretionary basis, we must have your approval to execute each transaction. | Item 3. Fees, Costs, Conflicts, and Standard of Conduct | <p>What fees will I pay?</p> <p>If you elect to invest with us in an investment management program, you will pay fees based upon the market value of the account. Fees are charged in advance on a quarterly basis based upon the market value of the account on the last day of the quarter. A detailed schedule of the range of fees that will be charged is included in the Form ADV Part 2A. We charge a fixed and/or hourly fee for financial planning and consulting services. You may elect to use the services of an independent manager that we may recommend. If you choose one of these managers, the fee that they charge will be exclusive of Topturn’s fees. We only offer non-wrap programs and as such, you should be aware that you will pay additional fees that are charged by the executing broker-dealer. These fees include custodial fees, reporting charges, margin costs, transaction and execution fees.</p> <p>Other fees and costs associated with your advisory services and investments might include charges imposed directly by a mutual fund or ETF in the account, which are disclosed in the fund’s prospectus.</p> <p>The more assets there are in your advisory account, the more you will pay in fees, and we may therefore have an incentive to encourage you to increase the assets in your account.</p> <p>You will pay fees and costs whether you make or lose money on your investments. Fees and costs will reduce any amount of money you make on your investments over time. Please make sure you understand what fees and costs you are paying.</p> |

What are your legal obligations to me when acting as my investment adviser? How else does your firm make money and what conflicts of interest do you have?

When we act as your investment adviser, we have to act in your best interest and not put our interest ahead of yours. At the same time, the way we make money creates some conflicts with your interests. You should understand and ask us about these conflicts because they can affect the investment advice we provide you. Here are some examples to help you understand what this means.

We also are the general partner of Omnistrat Fund, LP a conflict arises when we recommend that an advisory client invest in the Fund and potentially earn more compensation from managing the client’s assets through the Fund.

Another conflict is created because we permit our employees to maintain personal securities accounts. Advisory representatives and employees may trade in a security you own or is considered for purchase or sale for you but are under no obligation to initiate the same transaction or recommendation for you. We have adopted policies and procedures that are intended to address these conflicts of interest. Our employees must follow our procedures when purchasing or selling the same securities purchased or sold for you.

Some of the supervised persons of Topturn are licensed insurance agents and a conflict exists when the purchase of an insurance product is recommended to an advisory client. We have procedures in place whereby we seek to ensure that all recommendations are in your best interest.
